## Eligibility Criteria and Fee structure for FIACTA Exit Exam 2024

**1. IACTA membership:** Candidate must be a life member of IACTA.

**2. For FIACTA Registered candidates:**

**A.** All FIACTA registered candidates who joined the course before 30.09.2022 (2022-24 session) are eligible to take the 2024 FIACTA exit exam.

**B.** Those candidates who registered for the FIACTA course from 01.10.2022 to 31.12.2022, need to produce a letter from their HOD about the joining date of the course. They will be allowed to appear for the exam. Their result will be withheld till they complete the 24 months of training. Once they produce a letter from their HOD/Institute head about the completion of the 24 months training, the result will be declared.

**C.** Candidates, who come under “one time permission” approved by GBM held on 10.02.2024 at Nagpur, where one time permission was approved for all candidates for late joining or lack of communication to ICCA about joining, are also allowed to take the FIACTA 2024 exit exam. Please communicate with your Head of Department, who has been informed about the eligibility of such candidates. Those candidates should attach a letter from HoD stating their date of joining their institute and the duration of the course attended by the candidate.

**D.** Exam fee for FIACTA registered candidates is Rs.12000/- which candidate should deposit along with the application form and write the transaction details on the application.

**3. For Direct Candidates:**

**A.** Those who have passed DM//DrNB/PDCC (2 year fellowship course or one year PDCC and one year after PDCC in cardiac anaesthesia as certified by the Head of Dept.).

**B.** Candidate who are registered for the DM/DrNB on or before 30.09.2022 and will complete two years of experience as part of the DM/DrNB course on 30.09.2024 are eligible to take the FIACTA 2024 exit exam. They should get a letter from the HOD about the date of joining the DM/DrNB course and stating that they will complete the 24 months experience by 30.09.2024 are eligible to take the FIACTA 2024 exit exam.

**C.** FIACTA Exit Exam fee for “Direct candidates” is Rs.15000/- which candidate should deposit along with the application form and write the transaction details on the application.

**4. Logbook:** a logbook of 100 cases should be presented during the exam. The logbook should be certified by the head of department or mentor. For candidates who are themselves heading the dept., self-certification is acceptable. The format of logbook is given on the website. The “Direct Candidates” (appearing after completion of DM/DNB/FNB/PDCC, or those who have completed 2 yrs. of their DM/DrNB course) need to submit their course logbooks only, signed by the HOD.

**5. Dates of examination:** 21<sup>st</sup> and 22<sup>nd</sup> September 2024.

**6. Exam center:** The exam will be conducted simultaneously at multiple cities across India. The selection of the cities for exam would be done by ICCA, depending on number of candidates applying for the FIACTA exit exam 2024.

**7. Application date:** Last date for application is 31<sup>st</sup> July 2024; last date for cancellation is 5<sup>th</sup> August 2024.

**8. Application form:** Completed forms along with payment details should reach ICCA office (either by email or surface mail) by 31<sup>st</sup> July 2024. After checking the eligibility and the receipt of payment at our end, confirmation will be sent to the candidates by email for their eligibility for the exam.

**9. Passing criteria:** To pass, candidate must score 50% marks separately, each in theory and practical.

**10. Cancellation of exam and fee refund:** Students who applied and paid the exam fee but later decide not to take the exam can apply for full refund up to the last date of cancellation. After the last date of cancellation, if any candidate is not willing to take the exam, they will forfeit their exam fee. If any candidate could not appear due to a genuine reason, he/she should write to ICCA with genuine reason for cancellation till the date of exam. The candidate should submit proof supporting the reason for not being able to take the exam. ICCA board will look into each case individually and if approved, they would be allowed to pay Rs.6000/- exam fee for the next year. The decision of the ICCA would be final in this. After the exam day, no request for a refund will be accepted.

**11. Re-evaluation of the result:** One can apply for re-evaluation within one week of the publication of the result. The re-evaluation request should be sent to [iccaregistrar@gmail.com](mailto:iccaregistrar@gmail.com). The Dean Exam will go through the re-evaluation process (only the total of the marks obtained, rechecking that all the questions attempted by the candidate are considered in making the total score). The dean exam will present the report to the ICCA registrar and will be presented for approval to the ICCA board. The board's decision would be final and cannot be further challenged at any platform in IACTA.

**14. Language of Exam:** The exam will be conducted in English Language.

**15. Logistic support:** Accommodation for 2 days during the exam will be facilitated by the center head on payment of actual amount.

**16. IACTA Kabeer Award:** The highest scorer of the FIACTA theory and practical combined will be awarded the "IACTA Kabeer Award."

**17. Award of fellowship certificates:** The fellowship would be awarded at the inauguration ceremony during the annual conference of IACTA (IACTACON 2025) at Cochin.

**18. Duration of validity of FIACTA fellowship:** The FIACTA fellowship is for 10 year period, and the fellows need to go for recertification after 10 years as per the protocol prescribed by IACTA.
