**Guidelines**

*Recertification is to ensure that the fellowship owner is in touch with the subject. FTEE recertification is to be done every 10 years. There is no need to recertify honorary recipients. Revalidation requires a score of 30 out of 100*

**The criteria and the scoring (total 100)**

- I. IACTA endorsed TEE workshops (maximum marks: 14): 2 marks each for every Invited lecture
- II. IACTA national conferences (maximum marks: 14): 2 marks each for every Guest lecture on TEE
- III. State/Regional level TEE workshops (maximum marks: 6): 1 mark each for every Guest lecture
- IV. Attended National TEE workshops as moderator or chairperson (maximum marks: 7): 1 mark for each of the activities.
- V. Attended National TEE workshops (maximum marks: 6): 1 mark for each workshop attended
- VI. Attended Regional / State TEE workshops (maximum marks: 3): 1 mark for each workshop attended.
- VII. Publication on echo original articles in indexed journals (maximum marks: 10): 3 marks for each publication
- VIII. Echo based case report in indexed journals (maximum marks: 10): 2 marks for each publication
- IX. Publication in IACTA Echo library (maximum marks: 5): 1 mark for each publication
- X. Conduct of a TEE workshop as organizing secretary/chairman/chief-coordinator: 5 marks
- XI. Examiner of a TEE exam: 5 marks
- XII. Publication of a book on echo: 10 marks
- XIII. Writing a Chapter on echo in a book: 5 marks

For items X to XIII there are no additional marks for more than one workshops/examinerships or publications.
