Following is the timeline for FIACTA (Paed) exit exam 2024:

- Date of notification inviting applications: 05.10.2024.
- Last date for application forms to reach ICCA office: 31.10.2024 (either by email or surface mail)
- Last date of withdrawal of application: 05.11.2024
- Last date to pay the exam fee for eligible candidates: 07.11.2024.
- Date of examination: 16th and/or 17th Nov. 2024 (Saturday and/or Sunday)
- Declaration of the result: before 30.11.2023.
- Award of FIACTA(Paed) certificate: IACTACON 2025, Feb. 2025, Kochi, Kerala.

**Eligibility criteria and Protocol for the FIACTA (Paed) exit exam**

1. Candidate must be a life member of IACTA.
2. The examination fee for the FIACTA (Paed) registered candidates for FIACTA (Paed) exit exam is Rs.12,000/-.
3. Those who have passed DM/FNB/DrNB/ PDCC (2-year duration) can apply directly for FIACTA (Paed) exit exam by paying a total fee of Rs 15000 (Rs.12000/- exit exam fee plus an additional registration fee Rs.3000/-). These direct candidates should submit a certification by the head of department (where they completed the DM/DrNB course) stating that they have spent one year in paediatric cardiac anaesthesia during their tenure of DM/DrNB course.
4. Candidates who apply for the exit exam but do not appear, will forfeit the examination fee. Students who could not appear due to medical reasons will have to pay Rs 6000 at the next attempt. However, the candidate should produce a medical certificate forwarded by HOD. The final decision will be taken by the ICCA office.
5. Completed forms to be reach the ICCA office on or before the last date of application either by email or surface mail.
6. PLEASE DO NOT PAY ANY FEE with the application form. Pay the fee only after your eligibility for exam is confirmed by ICCA office and you are asked by email to pay the fee.
7. ICCA board will check your eligibility for FIACTA (Paed) exit exam. Those who are eligible, will be informed to pay the exam fee with the amount mentioned. These candidates will be expected to pay the prescribed amount to IACTA as per the procedure mentioned in application form. Those who are found “not eligible”, ICCA board will inform them the reason of their “non-eligibility” by email.
8. Logbook of 50 cases, certified by the head of department or mentor. For candidates who are themselves HODs, self-certification is acceptable. The logbook of FIACTA (Paed) students to be countersigned by the head of the institution. Those appearing aer completion of DM/DrNB, need to submit their course logbooks only.
9. Syllabus of FIACTA (Paed) can be downloaded from the website [www.iacta.co.in](http://www.iacta.co.in).
10. The examination shall consist of Theory and Practical (clinical examination & Viva voce) The distribution of marks would be as following:

**A) Theory: Duration: 3 hours; Marks: 100 (passing marks 50 or above)**

The question booklet contains 10 questions of 10 marks each.

**B) Clinical examination & Viva voce:**

One long case	: 100 marks
Two short cases (75 marks each)	: 150 marks
Table Viva	: 100 marks
Table 1: X-ray, ECG, Echo (50 marks)	
Table 2: Equipment, drugs, ABG (50 marks)	
Academics	: 50 marks
(Logbook, Scientific presentations, Publications)	

**Total marks: 400 (passing marks 200 or above).**

**Candidates need to secure 50% marks in separately in theory and practical to be pass the exam.**

11. For passing the examination, candidate is required to score 50% marks in both theory and practical separately.
12. Last date for application: 31<sup>st</sup> October 2024.
13. Last date for cancellation and request for refund of exam fee paid: 5<sup>th</sup> November 2024.
14. Last date to pay the exam fee for eligible candidates: 07.11.2024.
15. Tentative dates of examination: 16<sup>th</sup> and/or 17<sup>th</sup> November 2024 (Saturday/Sunday).
